Executive Summary

It was March 2019. At a dinner in Washington, President Jair Bolsonaro summed up what would be his four years in office: "we have to deconstruct a lot, undo a lot and then start doing it again." The deconstruction had already begun in January of that year: within the reach of Bolsonaro's pen, Executive Orders triggered institutional reforms of wide effect. The climate and environmental sector was one of the priority targets of deconstruction, to use the term chosen by the president, since ideological battles were disguised in it.

In 40 months of Bolsonaro's government, more than 140 thousand acts relating to environmental and climate policies have been published. From this universe, applying the methodology and typology developed by POLÍTICA POR INTEIRO, we identified 2,189 infralegal acts relevant to climate and socio-environmental policies in Brazil. Federal Official Gazette (DOU). Among them, 855 contributed to the deconstruction process. From this set, we conclude that 401 acts require immediate action, between revocations and revisions. This total contains measures issued at both the presidential and ministerial levels, coming from various cabinets and not only the Environmental one, as we may refer to the 48 acts of the Ministry of Agriculture, Livestock and Supply.

DIAGNOSIS




Figure 1. The process of selecting Executive acts for Reconstruction.

A thorough analysis of these acts, together with official speeches, pointed to a pattern of signals and guidelines from the government of Jair Bolsonaro in relation to the socio-environmental and climate agenda. The document Reconstruction: 401 acts of the Federal Executive Branch (2019-2022) to be repealed or revised to reconstitute the Brazilian climate and environmental agenda encapsulates the first four-year cycle of federal administration monitored by the POLÍTICA POR INTEIRO. The production of this report also allowed a reflection on the methodology established to classify climate and socio-environmental policies in Brazil. Understanding the movements of the Federal Government captured daily since January 1, 2019, through an algorithm exclusively developed for this purpose and human curation, allowed us to understand the dynamics of The Deconstruction method. And then propose the method of Reconstruction, which permeates various economic sectors and areas of Public Policy.

In addition to what has been deconstructed, this work allowed us to observe what remained standing. Some policies were not completely dismantled because they were based on laws and, therefore, were protected from the executive's own devices. In addition, the configuration of forces of the Congress in 2019 and 2020 halted bombs dropped by the go-

vernment. However, in the last two years, this reality has changed, especially in the House of Representatives, causing the deconstruction agenda to advance through legislative proposals as well. The expecta-

tion is that, even with an alternation in the presidency of the Republic, the interest in advancing anti-environmental agendas will continue in the House and Senate.

THE DECONSTRUCTION METHOD




Figure 2. Distribution of acts. Source: Política por Inteiro.

The National Congress will also be part of the battle for resources to enable the implementation of Brazil's climate commitments. Countering the current lack of expression, disorganization and lack of transparency of public spending on the

climate agenda, we advocate the establishment of a "climate budget" in the formulation of the medium-term planning of the 2024-2027 multi-year plan, to be voted on in 2023 by Congress. In this way, mitigations of greenhouse gas emissions and

adaptation measures to climate change can be inserted in a transversal way in public policies, in areas such as agriculture, energy, urban mobility and solid waste.

That is, the reconstruction will pass not only through the Planalto presidential palace, but it'll have to count on support at the Congress. And also on the constitutional protection of the Judiciary, activated several times in recent times to ensure that the "ecologically balanced environment" is a fundamental right in our Constitution.

The Reconstruction process must

bring back credibility to Brazil, which means reconstituting our ability to attract international investments and establish trade and economic partnerships beneficial to our society. The dismantling of climate and socio-environmental policies was inserted in a context of erosion of Brazilian democracy. And its Reconstruction involves putting Brazil back on the path to becoming a green power, involving the State, the private sector and the civil society, on a broad front driven by a common purpose, with shared and fair benefits.

The Deconstruction Method and a Roadmap for Reconstruction

In the document Reconstruction, the application of the Deconstruction Method in public policies in different sectors related to climate and environment is described. For each topic, we show how the Executive Orders were being piled up and led to the dismantling process. We also

point out ways to reconstitute what was destroyed and to advance the agendas. A summary table with the methods of Deconstruction, Reconstruction, and their respective reference acts is shown below. A complete list of all acts is available in the full study.
